

## **Organizational Sign-On Statement in Support of Atrocities Prevention**

We, the undersigned # [number] organizations encourage congressional action in support of strong U.S. government efforts to prevent violent conflict, avert mass atrocities, and protect civilians threatened by such crises.

Preventing violent conflict and mass atrocities is a core national security interest of the United States. Right now, over 50 million people have been displaced by conflict worldwide - the highest number since World War II. This has required growing expenditures to support life-saving humanitarian assistance and has led to other cost-intensive interventions. These crises have also resulted in increased instability with long-term consequences for countries and regions around the world, feeding into the possibility for repeated and expanded cycles of violence. These threats to U.S. security and interests can be mitigated with robust investments in prevention.

We believe that diplomatic and development tools are the most cost effective and uniquely capable of addressing the root causes and drivers of violent conflict. By addressing the core issues, these tools help to support the creation of resilient societies that act as a bulwark against violence. However, proper prioritization and investments are required for these tools to have widespread and sustainable impact.

**In order to ensure that efforts to prevent atrocities and violent conflict are successful, we urge the U.S. Congress to authorize, fund, and strengthen the growing number of prevention-focused tools managed by the Department of State and U.S. Agency for International Development as well as to authorize the high-level interagency policy committee represented by the Atrocities Prevention Board.**
